Looking back: LATCAM Webinars and Events June - November 2022













June 15

Public health problems, coupled with the Covid-19 pandemic, have strained systems around the globe and have highlighted the importance of health system sustainability. Today more than ever, achieving access to high quality health care and advances in science and technology is one of the goals of every country.

This is why the Movement Health 2030, a group led globally by Roche and the Copenhagen Institute for Future Studies, was born in 2020 as a non-profit organization that articulates the public and private sector to transform the world's health systems, addressing the biggest challenges of the sector by strengthening public policies and developing innovative and scalable solutions.

The distiguished speakers on the virtual panel of our Patron's webinar were **Rolf E. Hönger**, Area Head Latin America at Roche Pharma; **Bogi Eliasen**, Director of Health at the Copenhagen Institute for Future Studies; and **Massimo Manzi**, Executive Director at the Costa Rica Health Chamber PROMED. The webinar was moderated by award-winning journalist and TV icon **Manuel Teodoro**, currently Director of Séptimo Día, the highest-rated TV program in Colombia.

Our panelists discussed the importance of collaboration between the public and private sectors in innovation and health policy strengthening initiatives such as MH2030; and how these can contribute to the transformation of Latin American health systems.

June 22

This webinar on **Gender Diversity**, **Equality and Inclusion in Swiss companies in Latin America** was organized jointly by LATCAM and the Swiss Chambers.

Gender Equality is at the heart of the UN Women's Empowerment Principles and No. 5 of the UN Sustainable Development Goals. Gender Shift is one of the megatrends on the Future Institute's Megatrend Map, which analyzes and defines crucial trends that impact society and economy now and over the next several decades.

Women are 51% of the world's population and responsible for about 80% of all commercial decisions worldwide. But that's not all!

Companies that invest in women, commit to gender equality and support female leadership and decision-making, typically outperform their competitors.

Research has shown that companies and non-profits with diverse, inclusive teams tend to make better business decisions up to 87% of the time. Eliminating gender discrimination is a key element leading to a boost in production.

According to studies done by McKinsey, companies that have more gender diversity are 21% more likely, those with more cultural and ethnical diversity even 33% more likely to experience above-average profitability.

More inclusion and equality lead to a higher degree of sustainability and resilience, which in turn results in the ability to deal more efficiently with crisis. All of these should be powerful long-term business objectives for any commercial enterprise.

Two consecutive panels featured top female leaders from Swiss corporations in Latin America:

Marion Braegger, CFO, Roche Pharma (Uruguay, Bolivia, Paraguay); Monique Clúa Braun, General Manager, Novartis (Argentina, Chile, Uruguay, Paraguay, Boiivia); Paola Cobo, General Manager, SICPA Ecuador; Lizzie Kennedy, Country Manager, Nestlé Paraguay; Karina Lerma, CEO, Fracht Mexico, and CEO/Founder, Valmik Logistics, Mexico; Susana Torres, President, Swiss-Chilean Chamber of Commerce; Ana Tuñón Orrico, Head of Diabetes Care, Roche (Central America, Caribbean, Colombia); and Bettina Zimmermann, CEO, Roche Peru.

Our panelists shared their stories, vision of leadership and understanding of being role-models. They spoke about what it means for recruitment and careers, when a company lives up to the principles of diversity, equality and inclusion.

We explored why this is absolutely crucial nowadays for longterm corporate success, and how their leading example can be and is already leveraged and multiplied to benefit others.
